To note:

Singapore Citizens who are on ComCare Long Term Assistance (LTA), previously known as Public Assistance (PA), will receive full subsidies for the treatment of conditions covered under CHAS. ¹ With effect from 1 January 2025.

- ² "Simple" refers to visits for a single chronic condition. "Complex" refers to visits for multiple chronic conditions, or a single chronic condition with complication(s). - ³ Capped at 24 visits for common illnesses per patient per calendar year, across all CHAS clinics. For common illnesses, it is not expected that more than four visits per month would be required.
- ⁴ Healthier SG enrollees with CHAS/MG/PG cards may choose either the existing CHAS Chronic Tier or Healthier SG Chronic Tier, that would best benefit them based on their medication needs. Subsidies applicable only at their enrolled Healthier SG GP clinic.
